2. Maintain in the United States of America or the Dominion of Canada, a warehouse, office or similar facility in a physical location, zoned for commercial or industrial purposes by the municipality wherein such facility is located; and
3. Have been an existing business entity for at least the three (3) full calendar years in the United States or Dominion of Canada prior to the date of application; and
4. Have paid the required initiation fees and annual dues, as set forth herein; and
5. Be recommended by the Executive Committee.

Membership in the Association is not transferable.
